ORDER

Hon'ble the Acting Chief Justice and Hon'ble Judges of this Court have been pleased to order that henceforth the Court of Additional Chief Metropolitan Magistrate-01 in each district be earmarked for dealing with all cases under the Environment Protection Act, 1986 including those relating to the respective Solid Waste Management Bye-Laws of the Local Bodies of Delhi, for the said judicial district. All such pending cases, in any district, shall stand transferred to the Court of Additional Chief Metropolitan Magistrate-01 of the said district.

Furthermore, all cases relating to the Delhi Pollution Control Committee for the entire NCT of Delhi, pending as well as freshly filed, shall continue to be dealt with by the Court of ACMM (Special Acts), Central, Tis Hazari Courts, Delhi.
