However, the Form No./Section No. of the processes remains unchanged for want of software update patch from Hon'ble eCommittee, Supreme Court of India and the same is yet not received.

The office has now received information that Hon'ble the Information Technology Committee, High Court of Delhi has been pleased to permit the courts functioning under the Delhi District Courts to utilize the manual/computer generated process format (as specified in the BNSS-2023) till the availability of modified templates in the CIS in terms of BNSS-2023 and also informed that this will be an interim measure, till software patch provided by the Hon'ble eCommittee, Supreme Court of India, is implemented.

This is for your information with a request to convey the same to the staff posted in the respective court for necessary compliance.
