2. If all the three Judicial Officers mentioned in column nos. 3, 4, & 5 against Police Stations/Investigating Agencies appearing from Sl. no.1 to 8 happen to be on leave or not available for any reason, then the bail applications of the concerned Police Stations/Investigating Agencies shall be placed for disposal as per law, before the Judicial Officer mentioned in column no. 3 immediately below that Sl. No. and in his/her absence, before the 1st Link Judicial Officer of that serial number and so on and so forth. In case of unavailability of all the three Jd. Judicial Officers

- mentioned against police stations/ Investigating Agencies at Sl. No. 8. the bail applications shall be placed before the Judicial Officer mentioned at Sl. No. 1 and so on and so forth.
3. The bail/urgent applications pertaining to Special Acts viz. NDPS Act, NCB, POCSO, NIA, MCOCA, TADA, Special Cell Cases, SC/ST Act, UAP Act, Drugs & Cosmetics and Official Secrets Act shall be dealt with by the concerned Designated Courts, New Delhi District.
 4. It is made clear that no additional P.A./Sr. PA. will be provided for disposal of bail applications.
