Judicial Officer mentioned against police stations/ Investigating Agencies at serial number 7, the bail applications shall be placed before the Judicial Officer mentioned at serial number 1 and so on and so forth.

The bail/urgent applications pertaining to Special Acts viz. NDPS Act, NCB, POCSO, NIA, MCOCA, TADA, 3. Special Cell Cases, SC/ST Act, UAP Act and Drugs & Cosmetics Act etc. shall be dealt with by the concerned Designated Courts, New Delhi District.

It is made clear that no additional P.A./Sr. PA. will be provided for bail applications.
