Note:-

- 1 If the Judicial Officer mentioned in the column no. 3 happens to be on leave or not available for any reason, then the Reader of the concerned court shall place the bail applications before the 1st Link Judicial Officer mentioned in column no. 4 for disposal as per law, and so on.
- 2 If all the three Judicial Officers mentioned in column nos. 3, 4, & 5 against Police Stations/Investigating Agencies appearing from Sl. no.1 to 6 happen to be on leave or not available for any reason, then the bail applications of the concerned Police Stations/ Investigating Agencies shall be placed for disposal as per law, before the Judicial Officer mentioned in column no. 3 immediately below that serial number and in his/her absence, before the 1st Link Judicial Officer of that serial number and so on and so forth. In case of unavailability of all the three Ld. Judicial Officer mentioned against police stations/ Investigating Agencies at serial number 6, the bail applications shall be placed before the Judicial Officer mentioned at serial number 1 and so on and so forth.

3. The bail/urgent applications pertaining to Special Acts viz. NDPS Act, NCB, POCSO, Special Cell Cases, SC/ST Act, and Drugs & Cosmetics Act etc. shall be dealt with by the concerned Designated Courts, New Delhi District.
4. *It is made clear that no additional P.A./Sr. PA. will be provided for bail applications.*
