ORDER NO. 39 / 2024 DATED: 01.05.2024

In order to take effective step towards redressal of grievances of working women against sexual harassment in working place (Prevention, Prohibition and Redressal Act 2013), Hon'ble Supreme Court of India in its order passed in Writ Petition(s) (Criminal) No(s). 113/2018 (Afshan Pracha Vs. Union of India & Ors.) has issued certain order and guidelines.

In view of the guidelines issued by the Apex Court of India in the order passed in above-mentioned Writ Petitions and consequent upon the direction of the Hon'ble High Court of Jharkhand, Ranchi vide letter No. 350/ Admn. Misc. dated 19.06.2018 with regard to constitution of the requisite (complaint) committee in the premises of Civil Courts, Khunti, to make the work place safe and having secure environment for women to work with decency, dignity and due respect, a requisite (complaint) committee was constituted during the year 2018 in Khunti Judgeship and since then the said committee is in function, and due to transfer of it's member, the said committee has been re-constituted time to time and the last commttee was re-constituted on 11.03.2024 vide Office Order No. 19/2024.

In furtherance due to joining of one lady judicial officer namely, Smt. Vidyawati Kumari in the capacity of SDJM-cum-Civil Judge (Jr. Div.)-cum-Judge-Incharge-cum-PM, JJ Board in this Judgeship, the requisite (complaint) committee is hereby re-constituted in this Judgeship, comprising as under mentioned:-
