Perused the Letter No. 26/Admn. Misc. Dated 06.01.2024 of Hon'ble High Court of Jharkhand, Ranchi as well as minutes of meeting of district Court Selection Committee of Civil Court, Ranchi held on 08.01.2024. The Hon'ble High Court has been pleased to approve the names of "Selected candidates" as well as "Wait List Candidates" for the appointment to the post of Peon/Orderly, Mali, Night Guard and Driver in Civil Court, Ranchi vide Advertisment No. 01/2023.

Accordingly, selected candidates for appointment to the post of **PEON, MALI & NIGHT GUARD** in Civil Courts, Ranchi be appointed in the pay scale of 5200-20200/- with grade pay of Rs. 1800/- (pay matrix 18,000/- Level-1 in 7th Pay) (plus other allowances as per rule). The selected candidates for appointment to the post of **DRIVER** be appointed in the pay scale of 5200-20200/- with grade pay of Rs. 1900/- (pay matrix 19,900/- Level-2 in 7th Pay) (plus other allowances as per rule).

Their appointment purely on temporary basis and is liable to be terminated at any time without notice.

The candidate should bring the original educational certificates and their attested copies etc. at the time of joining. They shall also bring the medical fitness certificate issued from the office of Civil Surgeon cum Chief Medical Officer. Candidates selected in reserve category must bring original Caste and Domicile certificate as required, duly issued by the competent authority of the state of Jharkhand. Selected candidates should also file an affidavit declaration to this effect that he is neither convicted nor any criminal case is pending against him and he will not take/give dowry.

The Registrar, Civil Court, Ranchi is directed to publish the result of "Selected candidates" as well as "Wait List Candidates" for the appointment to the post of Peon/Orderly, Mali, Night Guard and Driver in Civil Court, Ranchi vide Advertisment No. 01/2023 in official website of Civil Court, Ranchi as well as in the Notice Board.
