**General Information/Selection of 10 PLVs**

**Ranchi dated 10/12/2024**

1. The list of shortlisted candidates for the interview shall be published on the official website of Civil Courts, Ranchi in due course of time after scrutinization of the forms received. The rejection list if any, shall contain the reasons for rejection of the application form.
2. There shall be interview carrying total of 30 marks out of which minimum qualifying marks will be 09. The candidate securing minimum qualification marks shall be selected in order of merit for each category (**Serving or Retired Teachers, Serving or Retired Doctors, Serving or Retired Army Personnels and Transgenders**). The selection of number of PLVs for each category will be decided by the Selection Committee.
3. The interview of the shortlisted candidates shall be conducted on **11<sup>th</sup> December, 2024** from **04:30 P.M.** at the premises of Civil Court, Ranchi. The short-listed candidates are directed to report at **02:30 P.M.** on the date of interview for collecting their respective Admit card from the Front Office of DLSA, Ranchi and for the verification of documents.
4. It is to be noted that no separate Admit card shall be sent through post to the candidates.




