The terms and conditions are as follows:-

1. The contractor shall provide sufficient number of Safai Karamcharies not less than two and one Supervisor for doing the cleanliness work i.e. cleaning, dusting, mopping etc. on each working day between 8:30 AM to 5:00 PM.
2. The contractor shall have to enter into an agreement with the District and Sessions Judge, Shimla with certain terms and condition for cleanliness work.
3. Safai Karamcharies/Supervisor must be in proper uniform.
4. The contractor shall quote rates with and without material for being used for the cleanliness purpose.
5. The material which shall be used in cleanliness work shall be of ISI mark.
6. The District and Sessions Judge, Shimla reserves right to reject any or all tenders without assigning any reason.
7. The tenderers shall have to furnish earnest money in the shape of Bank draft or Bank guarantee at the rate of 2 per cent of the quoted amount and any tender received without requisite tender fee shall be liable to be rejected straightway.
8. The successful tenderer shall have to deposit the performance security within a week to the extent of 5 per cent of the contract amount which shall be retained by

the District and Sessions Judge, Shimla for a period of two months from the date of its furnishing, if the cleanliness/sweeping work is not found upto the mark then such performance security shall also be liable to be forfeited to the District and Sessions Judge, Shimla besides exercising the option by the District and Sessions Judge, Shimla for cancellation of the contract.
