- b) For the post of Driver-II, Orderlies, Chokidar, the candidate must have passed 10th (Matric) examination from any recognized Board..



Note: For the post of Driver-II, in addition to other requisite qualifications, the candidate must possess a valid driving license (LMV/HMV) and shall produce a Medical Certificate to the effect that the candidate is fit to drive the vehicle.

II) Domicile:

The candidate should be domicile of UT of Jammu and Kashmir possessing a domicile certificate in terms of Notification issued by the General Administration Department of UT of J&K vide S.O. 166 dated 18.05.2020.

A) Process Server/Orderlies / Chowkidar

Candidates who will apply for the posts of Process Server, Orderly/Chowkidar, shall have to appear in the interview/viva voce. The selection for the said posts shall be made on the basis of merit obtained in the interview/viva voce only.

Driver-II.

Candidates for the post of driver shall have to undergo the written test to determine the general knowledge and the traffic rules. On the basis of merit obtained in the written test the candidates shall be called for determining the driving skill test in the ratio of 1:5.
