

Sub: Filling up of one post of Personal Assistant on deputation basis in Central Government Industrial Tribunal cum Labour Court, Jabalpur- regarding.

It is proposed to fill up one post of Personal Assistant on deputation basis in the Central Government Industrial Tribunal Cum Labour Court, Jabalpur initially for a period of three years or till post is filled up by way of regular appointment, whichever is earlier, on the following terms and conditions: -

1. Personal Assistant

- i) One post of Personal Assistant in Level-6 in the Pay Matrix of 7th CPC Scale- Rs.35400-112400.
- ii) As per the existing Recruitment Rules, the post may be filled up on deputation basis from the candidates: -
 - a.) Holding analogous post on regular basis; or
 - b.) With 10 years regular service in the Stenographer Grade in the Pay band-I 5200-20200 with Grade Pay Rs.2400 (Pre-revised) (Pay Level-4 in the Pay Matrix of 7th CPC)
- iii.) Deputation (Duty) Allowance shall be as per the guidelines issued by the DoPT's O.M No. AB-14017/61/2008-Estt. (RR) dated 13th October' 2015.

2. The candidate selected will have the option to draw pay as mentioned above (as per 7th CPC) or draw pay in the current post plus Deputation Allowance.

3. Being differentials in basic pay, the selected candidate will get enhanced emoluments as per pay rules.
4. The period of deputation will ordinarily not exceed three years.
5.
