02. The Vendor should provide the minimum warranty period of 2 years.
03. The Vendor is required to execute service level agreement for providing warranty.
04. The supply should be made within a week from the date of receipt of the supply order and has to be installed with required software in the location as directed by this office at their own cost. Failing which the orders placed will be liable for rejection.
05. Machine should be in accordance with the specifications, otherwise the same is liable for rejection.
06. The right of acceptance or rejection of the tender without assigning any reasons rests with the undersigned.
07. The damaged machine if any found at the time of installation shall be replaced immediately.
08. As the payment will be made by preparing bill in Khajane-2, successful tenderer have to submit bills in duplicate along with copy of bank pass book, PAN, receipt ID if available soon after the installation of machines.

10. The tenderer should send the expert technician to install the system to the respective courts and provide free training to atleast two officials working at the place of installation.
11. The tenderer should assure prompt and timely service as and when required, without causing any delay.
12. The payment will be made by this office after installation of devices, ensuring satisfactory working and only on receipt of stock certificate from the concerned Courts.
13. Safety box to the biometric device has to be provided by the vendor.
14. The tenders received after the due date will not be entertained at any circumstances.
