2. No Candidate shall be allowed to enter into the Examination Hall after 30 minutes of commencement of the examination and to leave the Examination Hall till the examination sitting is over.
3. No T.A. and D.A. will be given to the candidates for appearing examination.
4. Candidates are advised to produce their Intimation Letter/Admit Card in the Examination Hall as and when required.

5. No bags and baggage will be allowed into the Examination Centre.
6. No candidate shall be allowed to enter into the Examination Hall with Mobile Phone, Calculator, Pan, Gutkha, Books, Papers and other articles except writing materials and the Intimation Letter/Admit Card.
7. The Authority reserves the right to cancel the candidature/ suspend the candidate from appearing the Examination/Test in case of detection of any misconduct and infringement to the Rules and Regulations of the Examination.
8. The Intimation Letter/Admit Card does not confer any right for appointment.
9. The Candidates are advised to keep the Intimation Letter/Admit Card with them till completion of the Recruitment Process since it is required to be produced at every stage of the Recruitment Examination.


