4. Doing legal research in legal aided cases and guiding assistant legal Aid Defense Counsel and law students attached with the office in legal research.
5. Proper client interviews at various stages for quality research work and representation at remand, trial and appellate stage,
6. All or any of the work of the Chief Defense Counsel as per assignment.
7. Any work/duty assigned by Legal Services Authority.

II. Job Profile for the post of Assistant Legal Aid Defense Counsel:-

1. Filing of cases, conducting trials in Magistrate trial cases,
1. Remand/ bail and other miscellaneous work,
2. Legal research in legal aided cases,
3. Visits to Prison and Legal Aid Clinics as per directions,
4. Providing assistance at pre-arrest stage as per directions,
5. Assisting Chief Legal Aid Defense Counsel and Deputy Legal Aid Defense Counsel(s) in conduct of legal aid cases,
6. Assisting in developing a defense strategy after sitting through all of the evidence collected by the prosecution and after hearing the accused's version of what happened during the alleged crime in question,

9. Updating legal aid seekers about the progress of their cases,


