The sealed tender will have to reach this office on or before 4.00 p.m. on 02-09-2024. The tenders shall pay an EMD for Rs. 25,000/- (Rupees Twenty five thousand only) by way of Demand Draft in favour of Pr. Judge Family Court Kalaburagi, failing which the tender will be rejected outright. There shall be two sealed covers, the cover No.1 shall contain the Demand Draft of Rs. 25,000/- and the cover No.2 shall contain Tender document along with valid certificate and relevant documents regarding authority of manufacturers and suppliers including VAT Registration. The sealed of tender cover will be opened at 4.00 p.m. on 03-09-2024, in the presence of tenderers or their representatives, if any in the chamber of Pr. Judge Family court, Kalaburagi.

1. The tender shall furnish interest free E.M.D. of Rs. 25,000/- by way of Demand Draft In favour of Pril. Judge Family Court Kalaburagi, payable at **State Bank of India**, Super Market Branch, Kalaburagi. The tenders without this Demand Draft are liable for rejection.
2. The rate quoted shall be valid up to the supply of furniture of the quantity required in full, are until further orders of the competent authority.

3. The rate quoted shall be inclusive of all taxes applicable.
4. The Demand Draft of EMD amount of successful bidder will be returned without any interest only after supply of furniture required in full and the Demand Draft of EMD amount of other bidder will be returned without any interest on the same day on Which the tender covers are opened.
5. Supply order will be placed before successful bidder only after receipt of required Budget from Hon'ble High Court.
6. The successful bidder shall deliver furniture to the needy courts of this unit as per Directions of the Prl. Judge Family Court Kalaburagi.

5. Each article shall bear manufacturer's trade mark or other distinguished mark in addition to the particulars specified in the indent with the certificate from the manufacturer that the tenderer is an authorized agent.
6. Supplier should replace all damaged or defective supply of furniture, defective packing while forwarding or handling during transit within 15 days if such report is received by this office.
7. Supplier should also note the size and materials etc., used which should be exactly in accordance with the specification annexed to this document.
8. Supplier should manufacture and supply in conformity with the tender with the specification avoiding the receipt of complaint of this office.
9. If the articles or furniture are not supplied in accordance with specifications, the entire supply of furniture will be rejected.
10. The supply should be made within 20 days from the date of receipt of supply order, otherwise the order will be cancelled and the EMD will be forfeited to the Government.
11. This office will make full payment only after inspection and after receipt of the materials and stock certificate from the concerned Court.
12. The payment will be made by way of Cheque issued by Treasury; Which will be delivered to the supplier after the receipt of furniture in full and after the compliance of above terms and conditions, irrespective of the stock certificate enclosed with the D.C. bills to the Treasury.
