The tenders are invited in two sealed covers from government approved suppliers for supply of the following wooden and steel furniture for the use of Needy courts in Bagalkot District.

COVER – I

Terms & Conditions:

1. Copy of firm registration certificate with validity date for supply of steel & wooden furniture, tax registration certificate and previous tax paid receipts.
2. Rate of each item of wooden & steel furniture shall be quoted in the specification only.
3. The validity of rates quoted shall be for one year and the same will not be changed for any reasons and circumstances.
4. The rate shall be inclusive of taxes and transportation charges.
5. The quantity of the articles will be altered according to the allotment available.
6. The tender can submit the tenders either person or through RPAD. The cover should be duly sealed and superscribed as "**TENDER FOR SUPPLY OF FURNITURE AS PER TENDER NOTIFICATION**"

7. The undersigned reserves the right to accept or reject any tender without assigning any reason.

COVER NO. II.

1. The E.M.D. of Rs. 1,81,600/- by way of D.D. of any nationalized bank in favour of Pril. District and Sessions Judge & Tender Bulletin Officer, Bagalkot, payable at Navanagar branch of State Bank of India. Tender will be rejected, if such D.D. is not enclosed in the bid cover-II.
2. If the supplier or the bidders fail to supply the furniture as per the supply order, the E.M.D. amount will be forfeited to the government.

The acceptance or rejection of tenders is at the discretion of the undersigned. The payment will be made after delivery of materials. The sealed tenders shall reach the undersigned on or before 03-02-2025 at 5.00 p.m. The sealed tenders will be opened before the Prl. | 02 | <p><u>Teakwood Clerk Table :-</u> Size : 122 cm x 76 cm x 76 cm top with laminated sheet backing 1.94 cm thick block board legs 4.44 x 4.44 cm finished section with Two drawers are provided on the right and left side. These are made out of 6 mm one side teakwood plywood cross bars of 5.03 x 2.54 cm section are used wherever necessary.</p> | 34 |

| 06 | <p><u>Steel Almirahs :</u> Size : 198 cm-H x 91.5 cm-W x 48 cm-D (including leg of 15.24 cm) fitted with four fixed shelves making five compartments double door with three way locking device and duplicate keys, all joints outside and inside should be spot or are welded and neatly finished by grinding. The outside corners should be rounded off to give good properly bent to U-shape of 25 mm width to ensure good strength and the outer edge of U-bent of the door lengthwise should be double folded and neatly finished. The shelves front side should be bent to U-shape neatly and finished to avoid any possible cuts to fingers and hand when handled. Longitudinal rib of 15.24 cm wide including bent of required shape should be provided and fixed to each door at its center. The breadth of the shelf in the Almirah should be to the entire width leaving about 12 mm gap from the shutter when it is closed. LOCKING DIVICE: Three way locking device with 10 gauge M.S. sheet for locking and lever plate, and with locking rod of 10mm dia with strong bracket at top and bottom to hold the locking rod with six lever lock should be provided. 65 mm size of lever strong lock to be fixed. Handle should be made out of brass cast alloy with nickel chrome plate. Lock should be of similar to Godrej type.</p> | 60 |

| 07 | <p>Steel Rack: Size: 1.80m x 0.90m x 0.375m overall with four upright and five panels, the uprights shall be slotted angle of section 40 x 40 x 2 mm and the panels of size 900mm x 375mm x 20 G. The panel should be fixed to the uprights by means of G1. Bolts of sizes 8mm x 16mm by providing 16 nos. standard gussets at corners. The rack shall be painted as per indenture's choice.</p> | 40 |
| 8 | <p>Iron Safe: Size: 58.5 cm H x 48.25 cm x 48.5 cm D of single door made of single continuous 3.17 mm GBP sheet thick best steel plate bent cold with joint at the bottom substantially made by putting a full plate at the 16 edges being bent cold and the corners welded. 5 mm thick plate is to be used for door. The safe will have single drawer at the bottom fitted with the best 6 lever lock. The door will be fitted with air patent lock having 6 levers with check keys viz., A, B, C in duplicate (2 sets) protected by drill and hammer proof steel plates and with independent keys for the drawers. The doors will be fitted with 32 mm dia. Pin and socket type door hinges (door bearings) fixed. The main door has to be fixed in 3 mm depth for the iron safe body. The filling compound all round the body will be of the best non conductive and water generating compound and capable of withstanding severe fire test without effecting contents. The fire proof chemicals have to be loaded 8.6 cm in between both inner and outer body wall. Fire and burglar resisting iron safe contents the chemical contents such as mica, alumina and asphalt are to be loaded invariably between the inner and outer walls of the iron safe.</p> | 1 |
| 9 | <p>Cash Box :- Of the following size with synthetic enamel spray painting as per the sample specified by the purchaser. Outer frame being made up of Strong Steel Sheet of at least 12 swg, with 1 & 2 keys double locking system and with keys in duplicate.</p> | 1 |

3. The payment will be made by way of e-payment after the furnitures are received intact and in good condition along with the inspection certificate issued by the competent authority.
4. If the furniture so supplied are found not in accordance with the specification, the entire supply will be liable to be rejected at your risk and the loss and shall liable to pay the cost of fresh tender.
5. Each article of furniture should bear the manufacturer trademark and also the seal of the inspecting authority.
6. The successful bidder shall deliver the furniture free on road at his own cost to the destination of the needy courts of this unit.
7. The Demand Draft of EMD amount of successful bidder will be returned without any interest only after supply of furniture required in full and the Demand Draft of EMD amount of other bidder will be returned without any interest.
