- 2. (A) (i) Candidates belonging to District Kargil only can apply for these posts and must have Ladakh Resident Certificate.
 - (B) Age as on 01-06-2024.
 - i) should not be below 18 years, and not above:-



- ii) 40 years in case of Open Merit Candidates.
- iii) 43 years in case of Reserved Category candidates.
- iv) 40 years in case of candidates in Government Service/Contractual employees.
- 3. The applicants must be in possession of the prescribed minimum academic qualification and must fulfill all other eligibility conditions as shown against the post, by or before the last date of submission of application forms.
- 4. The prescribed fees for applying to the above said posts is Rs. 300/-(Rupees Three Hundred only) which shall be non refundable and shall be paid through demand draft of J& K Bank payable in the name of Principal District and Sessions Judge Kargil.
- 5. Application Form annexed with this advertisement as Annexure "A" along with the prescribed fee shall be received through offline mode in this office.
- 6. Notification regarding interview/test will be issued separately.
- 7. The persons who are already engaged on adhoc or daily wage basis in the subordinate Courts of District Kargil shall be eligible to apply irrespective of the minimum and maximum standards of age and academic qualification, and if approved by the competent authority, they can be given relaxation in the minimum standards of age and academic qualification.

- b) Candidates shall submit the Application Form/fee payment receipt in the office of Principal District and Sessions Judge Kargil w.c.f.01-06-2024 to 15-06-2024.
- c) The in service candidates/contractual employees shall submit photocopy of the filled up offline Application Form through proper channel viz, the concerned DDO. In the event of failure of the candidate to route the application through proper channel, his/her eligibility shall be deemed as if he/she is not an in service candidate.



- d) Any qualification/experience acquired after last date of receipt/submission of Application Forms i.e. 15-06-2024 shall not be taken into account for any purpose.
- e) The prescribed qualifications reflect the bare minimum requirement of the job and mere possession thereof shall not entitle a candidate to be called for test/interview.
- f) Call letters/Admit card shall be issued individually however, wide publicity shall be given through print and electronic media, official https://kargil.dcourts.gov.in of the Principal District and Sessions Court Kargil about the venues, dates of the test/interview for the information of the candidates.
