

2. The candidates shall have to produce all original certificates/testimonials at the time of their interview, alongwith self-attested photocopies of the same.
3. Any candidate who fails to produce his/her original certificates/testimonials may forfeit his/her candidature.
4. Only those candidates shall be allowed to appear in the interview who fulfill all the notified eligibility requirements.
5. Mere figuring of roll number of a candidate in the interview list may not entitle a candidate for any appointment which shall be subject to scrutiny of all testimonials under rules and his/her eligibility for the interview.

7. In the event of any deficiency found at the time of interview with reference to the eligibility of any candidate, such candidate may not be allowed to appear in the interview/test.

9. The acknowledgement/receipt issued to the applicants at the time of submitting their application forms shall be treated as their roll numbers.


