The District Legal Services Authority, Kargil is going to induct 14 Para Legal Volunteers (PLVs) for empanelment of 12 PLV's in Police Stations of district Kargil under scheme for **Empanelment of PLV's in Police Stations For Missing children** and two PLV's for District Kargil, which stands vacant. As such applications in standard form are invited from intending candidates of the following groups of people residing in Kargil district.

Teachers (including retired teachers)/ Retired government servants and senior citizens/ M.S.W students and teachers/ Anganwadi Workers/ Doctors/ Physicians/ Students and Law students (till they enrol as lawyers)/ Members of Non Political, service oriented NGO's and clubs/members of women neighbourhood groups, Maithri Sanghams and other self help groups including of marginalised/ vulnerable groups/ educated prisoners with good behaviour, serving long term sentences in prison/ any other person whom the District Legal Services Authority or Tehsil Legal Services Committee deems fit to be identified as PLV's.

Last date for the submission of the application is **07.04.2025** and the interview will be held on **09.04.2025** at District Court Complex, Kargil at **10:00 AM**.

Such composition is made only to meet the requirement for covering the entire district for spreading out activities of DLSA, Kargil.

**Eligibility:**

1. He/She must be citizen of India.
2. He/ She is not accused of any criminal case.
3. The minimum age for the selection of PLV's should not be less than 18 years as on the date of advertisement.
4. The candidate should have minimum qualification of Matriculation with a capacity for overall comprehension who do not look up to the income they derive from their services as PLV's and who have a mind set to assist the needy in the society coupled

with the compassion, empathy and concern for the upliftment of marginalised and the weaker section of the society.

**Note:**

**The work of the PLV's does not carry any salary, remuneration or wages except the Honorarium fixed by the DLSA from time to time.**

Further, reasonable expenses incurred by PLV's for eg. Bus, Postage, Telephone Charges etc. , may be reimbursed by the TLSC/DLSA/SLSA on production of proof. The duties, function and remuneration of the PLV's shall be governed by NALSA Scheme for the Para Legal Volunteers and regulation in this regard from time to time.

**Date and Place for Submission of Application:**

The filled up Prescribed application along with self attested copies of certificates in respect of age, qualification and proof of residence along with work experience if any should reach the office of the DLSA Kargil by **09.04.2025 at 4 PM.**

**Method of Selection:**

1. Incomplete application will be rejected without assigning any reason. No application will be entertained after the last date fixed.
2. The Selection of PLV's shall be made by the selection/ recruitment committee of DLSA, Kargil and the candidates shall be selected through an interview/ personality test. If it appears to the authority that the number of applications are huge then a preliminary screening of the applications may be done to shortlist the number of candidates. The basis of screening/ elimination will be decided by the selection committee after receiving the applications.
3. In case of any objection regarding the enlistment of PLV's the decision of the selection/recruitment committee of the DLSA, Kargil shall be final and binding on all concerned.
4. Canvassing directly or indirectly will disqualify the candidate.
