Application in the prescribed format is invited from the desirous candidates having requisite qualification and experience along with supporting documents as required under Rule-5 and 6 of the Family Courts (Orissa) Rules, 1990 for appointment to a vacant post of Counsellor in the Court of the Judge, Family Court, Bargarh in the district of Bargarh. The Counsellor shall be appointed by the Hon'ble High Court of Orissa.

1. ELIGIBILITY & QUALIFICATIONS OF COUNSELLOR:

A candidate, in order to eligible for the above post shall,

- (i) be a citizen of India
- (ii) (a) have passed Master's Degree in Sociology or Psychology, having minimum 3 years experience in family counseling.

Or,

(b) have a degree in Social Science preferably in Sociology or Psychology and he/she must be above the age of thirty five years working in the field of social service and welfare activities and engaged in promoting the welfare of family and child care.

{{Candidates having requisite qualification mentioned in Sl. No.(a) shall be given preference over the candidates having requisite qualification mentioned in Sl. No.(b)}}

- (c) be able to speak, read and write Odia and have passed test in Odia equivalent to the M.E standard.
- (d) be of sound health, good physique and free from organic defects or bodily infirmity and
- (e) have not more than one spouse living.

2. FUNCTIONS OF A COUNSELLOR:

The function of Counsellor shall be regulated in accordance with the terms and conditions laid down in the Family Courts (Orissa) Rules, 1990 and amendments made there under from time to time.

3. FEE OF A COUNSELLOR:

The Counsellor shall be entitled to retainer fee of Rs.6000/- (Six thousand) per month and assisting fee of Rs.1000/- (One thousand) only per day of their

actual work, in view of Government of Odisha Law Department Resolution No.6839 dated 23.04.2025.

4. DOCUMENTS REQUIRED:

- (i) Self attested photo copies of all Educational qualification certificates.
- (ii) Experience certificate in family counseling/ social service and welfare activities and engagement in promoting the welfare of family and child care:
