Pursuant to the instructions of the Hon'ble High Court of Orissa, Cuttack imparted in their letter No. 4221 dated 10.03.2022, applications are invited from the desirous candidates having requisite qualification and experience along with supporting documents as required under Rule-5 and 6 of the Family Courts (Orissa), 1990 for appointment to the vacant post of Counsellor in the Court of the Judge, Family Court, Jeypore. The Counsellor shall be appointed by the Hon'ble High Court of Orissa, Cuttack.

1. ELIGIBILITY AND QUALIFICATIONS OF COUNSELLOR.

- (a) He/she must be a citizen of India,
- (b) He/she must have passed Master's Degree (in Social Science preferably in Sociology or Psychology)
- (c) He/she must have minimum experience of 3 years in family Counseling.
- (d) He/she must be able to speak, read and write Odia and have passed test in Odia equivalent to the M.E. standard.
- (e) He/she must be of sound health, good physique and free from organic defects or bodily infirmity and
- (f) He/she must not have more than one spouse living.

Provided that where such persons are not available, persons above the age of thirty-five working in the field of social service and welfare activities and engaged in promoting the welfare of Family and Child Care with a degree in (Social Science preferably in Sociology or Psychology) shall be eligible for such appointment:

2. FUNCTIONS OF A COUNSELLOR:

The function of Counsellors shall be regulated in accordance with the terms and conditions laid down in the Rule-8 of the Family Courts (Orissa) Rules, 1990 and amendment made there under from time to time.

3. **FEE OF A COUNSELLOR:**

As per Rule-33 of the Family Courts (Orissa) Rules, 1990, the Counsellor shall be entitled to assisting fee of Rs.788/- (seven hundred eighty eight) only per day of actual work.

4. **DOCUMENTS REQUIRED:**

- (i) Self attested Xerox copies of the all Educational qualification certificates.
- (ii) Experience certificate in the field of social service and welfare activities and engaged in promoting the welfare Family and Child Care with a degree in (Social Science preferably in Sociology or Psychology) shall be eligible for such appointment:
