

The candidates who do not receive the admit card on or before 23.02.2024, they may obtain a duplicate copy thereof from the Office of the District Judge, Koraput Jeypore on 24.02.2024 on proper application and production of identity proof.

The candidates are directed to bring admit cards along with the admit card of their Written Examination.

The candidate shall bring any one of the documents in support of his/her Identity i.e Voter Card/PAN Card / Aadhar Card or any other proof. Further the candidates shall bring all their Original Certificates i.e. Academic qualification/Cast Certificate if, any.

The candidates reporting after the commencement of the test shall not be allowed to appear at the Computer Science Test (Practical / Typewriting Test).

The candidates are instructed to report in the Examination Centre one hour prior to the commencement of the Examination.
