A Walk-in-Interview of the desirous Para Legal Volunteers (PLVs) of D.L.S.A., Koraput-Jeypore and T.L.S.Cs, Koraput, Laxmipur, Kotpad, Borigumma, Dasamantpur, Semiliguda, Lamtaput will be held on **26.02.2026 at 1.30 PM** at **Conference Hall of ADR Building, Jeypore** for selection and deputation at Jeypore Town Police Station for assisting the parents, guardian and family members of missing children.

**SCORE OF WORK & ELIGIBILITY CRITERIA**

- Service of Para Legal Volunteers:** Services of Para Legal Volunteers shall be utilized by deputing them at Jeypore Town Police Station to assist the parents, guardian and family members of missing children.
  - Two Para -Legal Volunteers shall be deputed in Police Station in two shifts that is from 8.00 AM to 2.00 PM and from 2.00 PM to 8.00 P.M.
  - The Para-Legal Volunteers would be required to submit a report every week to DLSA regarding the work done during the week and any matter regarding special attention which comes to his/her notice in a prescribed format.
- Rate of remuneration:** Para-Legal Volunteers shall be paid an honorarium of Rs.500/- per day.
- Qualification and Age Criteria:** Qualification required to be selected as a PLV is Intermediate (10+2). The age criteria are 25-45 years, except in case of Law Students for which the age criteria is above 18years.
- Tenure of engagement:** PLVs shall be empanelled initially for a period of **six Months** which shall be further extended on recommendation of the DLSA Secretary on the basis of their performance.
