Civil Judge and J.M.F.C., Mudigere, to carrying records, Properties and Treasury Box along with the Presiding Officer and four staff members from Mudigere to Kalasa itinerary court on every working Monday's. 1. The intending Bidders can obtain tender application from the office of the Prl. District and Sessions Judge, Chikkamagaluru on payment of cost of Rs. 100/- in person.
2. The intending Bidders who intends to obtain the tender documents by post or courier has to send the amount of Rs. 100/- through M.O. in the name of Prl. District and Sessions Judge, Chikkamagaluru and transmission charge of Rs. 50/-. However, the tender inviting Authority is not responsible for any delay in transit of the tender forms.
3. The intending Tenderers shall deposit an E.M.D. of Rs.5,000/- by way of Demand Draft drawn in the name of Prl. District & Sessions Judge, Chikkamagaluru, payable at State Bank of India, Main Branch, Hosamane Extension, Chikkamagaluru. The E.M.D. deposited by the successful Bidder may be adjusted towards security deposit on award of contract. Such security deposit shall be interest free which will be refunded after expiry of the contract or its termination and the E.M.D. will be returned to the unsuccessful Tenderer immediately by way of the same D.D.

4. The Tenderer shall submit the tenders in Two Sealed Cover System. Cover No.1 Technical Bid shall contain all the information and documents mentioned in the application form along with a Demand Draft for Rs. 5,000/- and the Cover No.2 Financial Bid shall contain quotation.
5. The Tenderer can submit the Tenders either in person or through Registered Post. The covers should be duly sealed and Superscribed as "TENDER FOR HIRING VEHICLE AS PER TENDER NOTIFICATION No. 3/2022-23 - COVER-I" and "TENDER FOR HIRING VEHICLE AS PER TENDER NOTIFICATION No. 3/2022-23 - COVER-II"
6. Interested Agencies/ Owners may submit sealed bids in the manner specified in the tender document to the office of the Prl. District and Sessions Judge, Chikkamagaluru on or before 19/09/2022 up to 5.00 p.m. The Tender will be opened on 20/09/2022 at 5.30 p.m. in the chambers of the Prl. District and Sessions Judge, Chikkamagaluru, in the presence of Tenderers, those who are present.

**ANNEXURE - A**

**TERMS AND CONDITIONS FOR HIRING VEHICLE.**

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire basis.

1) The hired vehicles, during period of contract, shall have all necessary valid M.V. documents such as : - Valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contact Carriage Certificate permit, proof of up to date tax payment etc. and D.L. of driver available all the times. The Department/ Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicle or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.

2) It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.

3) The bidder shall bear all cost on account of fuel, oil, spares comprehensive insurance, repair, and maintenance etc., of the vehicle and other costs shall be borne by the bidder.

4) In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.

5) In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.

6) The vehicle shall report for duty on every working Monday's at about 8.30 a.m., before the Addl. Civil Judge and J.M.F.C., court at Mudigere.

7) The Vehicle shall not be more than three years old and also in good running condition during the period of contract.

8) If services are found to be unsatisfactory, the Client shall give one month notice and terminate the agreement.

9) The payment will be made on monthly basis on submission of pre-receipted bill duly signed.

10) In case of the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.

11) If the bidder violates any of the terms of the contract, the Prl. District and Sessions Judge, Chikkamagaluru shall forfeit the entire amount of the security deposit.
