### ANNEXURE - A

### TERMS AND CONDITIONS FOR HIRING VEHICLE.

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire basis.

1} The hired vehicles, during period of contract, shall have all necessary valid M.V. documents such as: - Valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contact Carriage Certificate permit, proof of up to date tax payment etc. and D.L. of driver available all the times. The Department/ Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicle or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.

2} It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.

3)The bidder shall bear all cost on account of fuel, oil, spares comprehensive insurance, repair, and maintenance etc., of the vehicle and other costs shall be borne by the bidder.

4} In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.

5]In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.

6)The vehicle shall report for duty on every working Monday's at about 8.30 a.m., before the Addl. Civil Judge and J.M.F.C., court at Mudigere.

7)The Vehicle shall not be more than three years old and also in good running condition during the period of contract.

8]If services are found to be unsatisfactory, the Client shall give one month notice and terminate the agreement.

9)The payment will be made on monthly basis on submission of pre-receipted bill duly signed.

10)In case of the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.

11]If the bidder violates any of the terms of the contract, the Prl. District and Sessions Judge, Chikkamagaluru shall forfeit the entire amount of the security deposit.
