The Hon'ble High Court of Karnatka vide Letter at reference No.1 above has given a direction to take suitable action to cause promotion to the cadre of Senior Sheristedars/ Bench Clerk Grade-I as per the Amended Rules referred at Sl.No.3 above and as

contemplated in Rule 4(4) of the Karnataka State Civil Services (Regulation of Promotion, Pay and Pension) Act, 1973 (Act 11 of 1974) and Rule 7 of the Karnataka Civil Services (Classification, Control and Appeal) Rules, 1957. In the backdrop of directions issued by the Hon'ble High Court, the following order is made.

**PART-A**  
**(Promotion)**

The following officials in the cadre of Sheristedars are PROMOTED to the upgraded post of SENIOR SHERISTEDAR/BENCH CLERK GRADE-I in the pay scale of 11400-21600 (as on 19.09.2009) and corresponding pay scales revised or extended from time to time with effect from the dates shown at Col.No.3 against their respective names in terms of Rule 4(4) of K.C.S (Regulation of Promotion, Pay and Pension) Act, 1973 and subject to condition of approval of the proposal pending before the Government of Karnataka with regard to Rule 7 of K.C.S (Classification, Control and Appeal) Rules, 1957.

The Promotion caused as above is subject to :

- (i) Any decisions or directions that may be taken or issued by the Hon'ble High Court in the matter of promotions and other service conditions.
- (ii) The Seniority in the cadre of Senior Sheristedar/Bench Clerk Grade-I inter se among the officials promoted from the cadre of Sheristedar / Bench Clerk Grade-II and the officials to be transferred from the cadre of Stenographer Grade-I (in the ratio 7:1) is subject to the decision that may be taken by the Hon'ble High Court.

- (iii) The above promotion is ordered subject to review at any time without notice and subject to the decision that may be taken with regard to the relevant question about the seniority and without prejudice to the Seniority of others who may ultimately be held to be senior to the promotee. In the event of any such contingency, the promotee shall be liable for reversion without notice.
- (iv) The official shall pass the Computer Literacy Test as per the Karnataka Civil Services (Computer Literacy Test) Rules 2012 and its upto date amendments, within the prescribed period, if not passed.
- (v) The above promotion is subject to the posting orders to be issued by the Hon'ble High Court of Karnataka with respect to Stenographer Grade-I who will transfer from said cadre to the cadre of Senior Sheristedar/Bench Clerk Grade-I.
