The sealed Tenders from the Manufacturers of Steel Furnitures are hereby called for supply of the following quantity of Steel Furnitures for the use of the Courts of Chikkamagaluru Unit and FTSC Court in Chikkamagaluru district. A detailed specification of the furnitures to be supplied is annexed to this Tender Notification.

Terms and Conditions:

1. The last date for submitting the Tender is **22/01/2024** upto **4.00 p.m** in the office. The tender for technical bid opened on **23/01/2024** at 5.30 p.m. in the chamber of the Prl. District & Sessions Judge, Chikkamagaluru, and Financial Bid opened on **25/01/2024** in the presence of the Tenderers, those who are present.
2. For Steel Furnitures good quality steel has to be used with 16 – 18 gauge steel as specified in the annexed specification.
3. The Quantity mentioned is tentative one and the same is subject to variation depending on the cost of the articles and rquirement.
4. The intending Tenderer can obtain Tender Forms from the Office of the Prl. District & Sessions Judge, Chikkamagaluru, on payment of cost of **Rs.200-00** in person.
5. The intending Tenderer who intends to obtain the tender documents by post or courier has to send the amount of **Rs.200-00** through M.O. and Transmission charge of **Rs.50-00**. However, the Tender inviting Authority is not responsible for any delay in transit of the Tender Forms.
6. The intending Tenderers shall deposit an E.M.D. of **Rs.10,000-00** by way of Demand Draft drawn in the name of **Prl. District & Sessions Judge, Chikkamagaluru**, payable at State Bank of India, Main Branch, Hosamane Extension, Chikkamagaluru.
7. The E.M.D. will be returned to the unsuccessful Tenderer immediately by way of the same D.D. and the E.M.D. of the successful Tenderer will be refunded on satisfactory supply of the furnitures.
8. The Tenderer shall submit the tenders in sealed Two Cover System. Cover No.1 shall contain valid certificates regarding approval from the D.G.S. and D rate contract along with relevant documents regarding authority of manufactures and suppliers including GST registrations along with a Demand Draft for **Rs.10,000-00**. The 2nd Cover shall contain the cost of furniture per unit, and total cost of furniture (including GST) for the required quantity as per specification enclosed to the Tender Form. (The Cover-1 to be superscribed as Technical Bid, the Cover-2 to be superscribed as Financial Bid).
9. The Tenderer shall furnish an unconditional warranty for a period of **THREE years**.
10. The Tenderer can submit the Tenders either in person or through Registered Post. The covers should be duly sealed and Superscribed as **“TENDER FOR SUPPLY OF STEEL FURNITURES”** as per Tender notification.
11. The Tender Inviting Authority is not responsible for accidental opening of the covers that are not properly superscribed and sealed as required before the time fixed for tender opening.

12. The Cover No.I will be opened first. If the Cover No.1 do not contain the Demand Draft for E.M.D. and other relevent documents, the Cover No.II will not be opened or considered.
13. The successful Tenderer has to supply the furnitures within 20 days from the date of Supply order in good condition and as per the specification. The Successful Tenderer has to execute a Bond undertaking to supply the articles within the prescribed period in good conditions as per specification and to carry out the obligations during the warranty period. Breach of conditions of the Bond will make the Successful Tenderer liable to pay damages / penalty that may be determined and imposed by the undersigned, besides forfeiting the E.M.D.
14. The successful Tenderer has to supply the furniture to the destination at their cost only that may be intimated by the undersigned in due course.
15. The Successful Tenderer before delivering the articles shall furnish a Certificate issued by the Department of Industries & Commerce, regarding the quality and the specification of the Steel furniture. Further, the Successful Tenderer shall affix the Firm Name & Address on the articles on furniture supplied.
16. The Successful Tenderer will be responsible for any damages to the articles during transit and in case of any damages, he has to replace the said article at his own cost.
17. The Successful Tenderer will be responsible for replacing or repairing the defective furniture during the warranty period free of cost and without any delay.
18. The right to accept or reject any tender without assigning any reason rests with the undersigned.
19. Articles supplied are subject to examination by the persons of the choice of the Tender Inviting Authority to ascertain the quality of the articles supplied. The Tender Inviting Authority has right to reject any articles.
20. The other terms and conditions for supply of furniture will be as prescribed by the Karnataka Small Industries Marketing Corporation Limited.
21. Payment will be made on satisfactory supply of the furniture within due date and on submitting bills in duplicate to the Tender Inviting Authority.
