So, the Judicial Magistrate, who is on duty as per the above mentioned revised programme, must get consent of the colleague Judicial Magistrate and then submit the application either for permission or for grant of Casual Leave in emergency contingency.

Further the Judicial Magistrates in Tiruchirappalli Taluk are hereby directed to look after the Dying Declaration duty for the year 2023 on the Taluk itself on considering the point of jurisdiction and distance.

If necessity arise, the above said tentative programme will be modified, the receipt of the same, is required to be acknowledged, at once.
