**ORDER**

In view of the Office Order No. 896/RG/DHC/2021 dated 30-12-2021 of Hon'ble High Court of Delhi, and as directed by the Ld. District & Sessions Judge (HQs), Delhi and in partial modification of duty rosters, it is hereby ordered that:

The Ld. Duty Magistrate of the day shall also perform the work of granting remand in case of fresh arrestees, granting of police custody from judicial custody, if required, discharge and formal arrest, he shall also extend the remand of UTPs (Under Trial Prisoners) through video conferencing, pertaining to North West, District at the time allotted as per annexure A (enclosed herewith). The UTPs under POC SO, SC/ST Act/TADA/POTA/NDPS/MACOC etc. shall be produced in the concerned court through Video Conferencing (Web-ex) in coordination with the Video Conferencing Staff w.e.f. 03-01-2022 to 15-01-2022.

The Ld. MMs (Reliever) of North-West District shall perform their duties normally as they were performing earlier, i.e., TIP, Inquest proceedings, Recording of Statements under section 164 CrPC etc. on daily basis.

**Note:**

1. The Jail Authorities shall send the custody warrants of Under Trial Prisoners for extension of remand through video conferencing well in time.
2. The staff of Video Conferencing room shall provide the list of Under Trial Prisoners, produced through Video Conferencing to the Ld. Concerned Courts.
3. The court working hours shall be strictly adhered to by all the Ld. MMs.
