ORDER

Hon'ble the Chief Justice and Hon'ble Judges of this Court have been pleased to make the following postings/transfers in the Delhi Higher Judicial Service with effect from 02.03.2022:-

Notes:-

1. The judicial officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.
2. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
3. The Court of ASJ-02, New Delhi, PHC shall henceforth continue to deal with fresh/pending cases filed before it being a Special Court under Section 22 of the National Investigation Agency Act, 2008 in terms of Notification No. I 11/2012-Judl/Suptlaw/1041-1045 dated 12.09.2013 issued by GNCTD. Any committed case thereto shall also be dealt with by the said court. It shall also continue to deal with all the pending cases under the Unlawful Activities Prevention Act as well as fresh such cases, to be filed before it as per the existing practice. All other cases pending before the said court shall be immediately withdrawn and assigned to the

newly created ASJ courts by the Principal District and Sessions Judge, New Delhi while ensuring equitable distribution.

4. The Court of ASJ-03, New Delhi, PHC shall henceforth continue to deal with fresh/pending cases filed before it being a Special Court for the trial of Scheduled Offences investigated by the National Investigation Agency in terms of Office Memorandum No.37/Legal/Spl. Court/Judge/NIA/Delhi-13082 dated 11.02.2019 as well as cases under Maharashtra Control of Organized Crime Act, 1999. Any connected case thereto shall also be dealt with by the said court. All other cases pending before the said court shall be immediately withdrawn and assigned to the newly created ASJ courts by the Principal District and Sessions Judge, New Delhi while ensuring equitable distribution.
5. The new court of ASJ-05, New Delhi, PHC is additionally designated as the Special Court under the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act and the Securities and Exchange Board of India Act as well as designated court to try sessions cases investigated by Special Cell, Delhi Police (other than those offences as mentioned in schedule of National Investigation Agency Act, 2008 which shall be triable by the court of ASJ-02 New Delhi, PHC only and other than MCOCA cases which shall be triable by the court of ASJ-03 New Delhi, PHC only).
6. The Principal District and Sessions Judge, New Delhi District shall transfer such number of cases under the National Investigation Agency Act, 2008 pending in his court to the court of ASJ-03 so as to facilitate their expeditious disposal.
7. The Principal Judge, Family Court, New Delhi District shall assign sufficient number of cases to the newly created court of Judge, Family Court, New Delhi District so as to ensure equitable distribution of work load.




