m. Cases where the sentence is the sentence of death and has not been commuted,

Cases where the sentence is for an offence against any law relating to any of the (H) matters enumerated in the List-I of seventh Schedule of the Constitution and,

(III) Cases, where the order referred to in sub-section (6) of Section 432 is passed under any law relating to any of the matters enumerated in List-I in the Seventh Schedule of the Constitution.

The Government remissions will be over and above the remission already permissible under the provisions contained in the Prison Rules and it is the remittance of sentence which is over and above the remission already contained in the Delhi Prison Rules, 2018 i.e. the period of remission being granted is to be deducted from total sentence.

The Government remission shall be granted to the convicts who are convicted by the Courts of Criminal Jurisdiction in the National Capital Territory of Delhi, lodged in the Central Jalis in NCT of Delhi and outside Delhi as on 26.01.2023.

This remission will also be granted to all the convicts who are on parole/furlough from the jall as on 26.01.2023 subject to the condition that there is no report of misconduct during the said parole/furlough or any other violation reported as per the rules/guideline.

This remission will be granted to only those convicts who have not been punished for any)all offence for the preceding one year i.e. 26th January 2022 to 25th January 2023.
