It is hereby notified for the general information of the public that the Bar Council of Tamilnadu and Puducherry had passed prohibitory order against the following advocates by resolution dated 10.12.2021:-

1.	Mr. E. Vimal Kumar, Ms. 382/2013, No. 27, Mariamman Kovil Street, Poonamalle 600 056.	Ms. 382/2013	Passed a resolution vide No.646/2021, by considering the complaint received against him under Sec. 35 of the Advocates Act, 1961 alleging that Mr. E. Vimal Kumar, Advocate gave life threat to the Complainant and her mentally retarded son and cheated her by receiving huge amount. Further, he received several sovereigns of gold from the Complainant and tried to misuse her property documents by forging the signature of the Complainant's husband and also leveled other serious allegations against the advocate. In connection with the above complaint, on 02.09.2021 at about 3 p.m., said Advocate Mr. E. Vimal Kumar along with an Advocate namely Mr. D. Pazhani entered into the Poonamallee Bar Association(Criminal) situated inside the Court Campus in an Inebriated mode, damaged the chairs and tables of the Association, abused the Secretary of the Association and

			others in filthy language and attacked the Secretary and he sustained injury. He has also given life threat to the Secretary of the Association. Further, when other Advocates in the Court restrained him, he did not listen to them and abused the Chairman, Bar Council in filthy language and made life threat to the Chairman, Bar Council. Based on the complaint lodged by the Secretary, Poonamalle Bar Association, a criminal case has been registered against him in Crime No. 1304/2021 under Sections 294(b), 323, 506(i) of Indian Penal Code, on the file of the Poonamallee Police Station, Chennai District and the same is under Investigation.
2.	Mr. B. Ilayaraja, No.145, Palayakara Street, Villivalam Village, Naickenpet Post, Kanchipuram Taluk & Dist 631 601.	Ms. 253/2013	Passed a resolution vide No.631/2021, by considering the complaint received against him alleging that he studied law degree while working in TASMAL and by suppressing the same, he got enrolled before the Bar Council in the year of 2013 and still working as a full time employee in the TASMAL.
