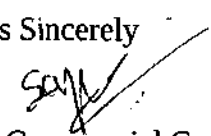
It is to apprise you that the Vth list of the record i.e 1335 Nos of consigned files of Fauzdari

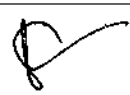

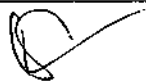
