ORDER

No. F.18/01/2002/Home (General)/ 12.5 – 135. In exercise of the powers conferred by Section 432 of the Code of Criminal Procedure, 1973, read with the Government of India, Ministry of Home Affairs Notification No. U-11011/2/74-UTL (i) dated 20.03.74 and Rule 1185 of Delhi Prison Rules, 2018, the Lt. Governor, Government of National Capital Territory of Delhi is pleased to award the Government remission on the occasion of the Republic Day on 26th January, 2022 at the scale mentioned below against each class of Prisoners, who were convicted by the Courts of Criminal Jurisdiction in the National Capital Territory of Delhi and confined in the Central Jails in NCT of Delhi and outside Delhi as on 26.01.2022.

Prisoners above the age of 65 years and for women prisoners:-

I.	Prisoners undergoing sentence above 10 years	03 months
II.	Prisoners undergoing sentence above 05 years and upto 10 years	02 months
III.	Prisoners undergoing sentence above 01 year and upto 5 years	01 month
IV.	Prisoners undergoing sentence upto 01 year.	20 days

(a) For all other prisoners:-

I.	Prisoners undergoing sentence above 10 years	60 days
п.	Prisoners undergoing sentence above 05 years and upto 10 years	45 days
Ш.	Prisoners undergoing sentence above 01 year and upto 5 years	30 days
IV.	Prisoners undergoing sentence upto 01 year.	15 days

However, the prisoners covered under following categories are not eligible for the above said remission:-

- (a) Prisoners awarded life imprisonment on or after 18/12/78 for an offence for which death is one of the penalty or whose death sentence has been commuted to life imprisonment.
- (b) Prisoners undergoing sentence in lieu of fine only.
- (c) Detenues under NSA and COFEPOSA.
- (d) Civil Prisoners jailed for evading Government dues.
- (e) Prisoners convicted for court-martial.
- (f) Prisoners convicted for espionage under official Secret Act.
- (g) Prisoners arrested under NDPS Act on/after 29/05/89.
- (h) Prisoners sentenced for crime against women under section 376 and 354 IPC. (Including allied sections)
- (i) Prisoners sentenced under 138 Negotiable Instrument Act and other Civil convicts.
- (j) Prisoner sentenced under POCSO Act.
- (k) "Exception" Categories of Prisoners specified in MHA Notification No. U-11011/2/74-UTL (i) dated 20/03/74 (relevant extract is reproduced below):-

The Government remissions will be over and above the remission aiready permissible under the provisions contained in the Prison Rules and it is the remittance of sentence which is over and above the remission already contained in the Deihi Prison Rules, 2018 i.e. the period of remission being granted is to be deducted from total sentence.

The Government remission shall be granted to the convict who is convicted by the Courts of Criminal Jurisdiction in the National Capital Territory of Delhi, lodged in the Central Jails in NCT of Delhi and outside Delhi as on 26.01.2022.

This remission will also be granted to all the convicts who are on parole/furlough from the jail as on 26.01.2022 subject to provisions of Prison Rules and the condition that there is no report of misconduct during the said parole/furlough or any other violation reported as per the

This remission will be granted to only those convicts who have not been punished for any jall offence for the preceding one year i.e. 26th January 2021 to 25th January 2022.
