

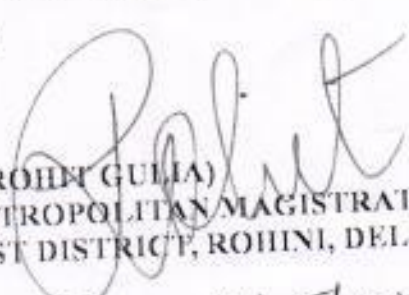
**OFFICE OF THE CHIEF METROPOLITAN MAGISTRATE:

The reader/ahlmad of concerned court staff is also directed that the Summary Trial Register & Fine receipt book of their court shall be utilised on that particular day.

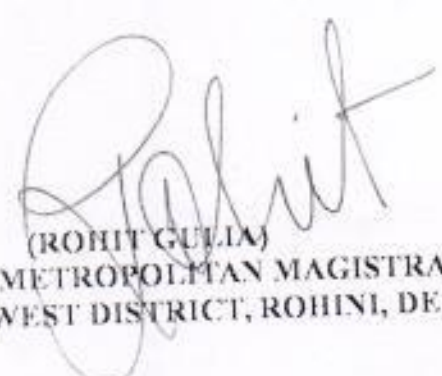
