

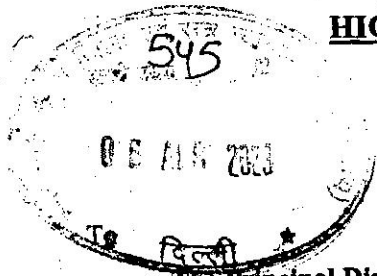



It is hereby notified for general information that the names of (1) Mr. **Amresh Kumar Sinha**, Son of Mr. Muneshwar Prasad Sharma and (2) Mr. **Rakesh Kumar Jha**, son of Mr. Deo Kant Jha both Advocates of Patna High Court who were enrolled as Advocates by the Bihar State Bar Council, **have been removed from the State Roll of Bihar State Bar Council**, Under Section 35(3)(d) of the Advocates Act, 1961, by Disciplinary Committee No. X of Bihar State Bar Council vide order dated 19.03.2023 passed in D.C. Enquiry No. 02/2022 on the basis of cognizance taken by the General Body of Bihar State Bar Council vide Resolution No. 70/2022 dated 24.04.2022, in the light of order dated 09.12.2021 passed in Cr. Misc. No. 40386/2021 (Ravindra Kumar Vs. State of Bihar)

Thus the names of Mr. **Amresh Kumar Sinha** (Enrolment. No. BR/914/1995 dated 25.05.1995) and Mr. **Rakesh Kumar Jha**, Advocate (Enrolment. No. BR/04/2017 dated 16.01.2017), both Advocates of Patna High Court are **removed permanently** from the State Roll of Advocates of Bihar State Bar Council, Patna as such they are debarred permanently from practicing as an Advocate in any Court or before any authority or person in India, from the date of this notification.
