

CIRCULAR

In order to properly maintain record of decided bail applications and smooth functioning of Courts/Bail Section of North-West District, the following practice shall be adopted with immediate effect :-

- (i) The Bail Section shall send all the decided bail applications including bail applications/anticipatory bail applications/any other bail applications along with the orders to the concerned courts of Ld. MMs including Mahila Courts.
 - (ii) The practice of consigning the decided bail applications/anticipatory bail applications/any other bail applications to the Record Room by the Bail Section discontinues immediately.
 - (iii) All Ahlmad posted in the magisterial courts are hereby directed to prepare miscellaneous file since the receipt of FIR from the concerned police station/investigation agency and attach all the miscellaneous papers including bail applications/anticipatory bail applications/any other bail applications /miscellaneous applications/remand papers/superdari papers/any other proceeding papers alongwith court orders. They are further directed to attach the said miscellaneous file with the Police challan/charge sheet as and when filed by the IO
 - (iv) All the Ahlmad are directed that no challan shall be put forward to Ld. MMs without complying the aforesaid direction.
- Non-compliance of the aforesaid directions shall be viewed seriously.


