 Go to 'Employees' -> 'My Employees'.

Discrepancy (If any) found, in the posting details i.e. either the list of employees does not contain the name of the employees actually posted in any given branch/court or there are names of employees who are actually not posted in the respective court or branch, the administration branch of concerned district may be contacted to apdate the said incorrect/incomplete particular/details.

All the administration branches may however get the entries corrected/updated through LAYERS seat only upon providing the requisite documents (transfer order, relieving report and joining report) of the respective employees to the LAYERS Seat, Tis Hazari Courts, Delhi. All the Branch in-Charges of Administration Branch shall also verify the employees of their respective Office Pool, or officers/officials on Deputation or in Diverted canacity. (If any.) In case, the Branch In-charge/Reader is traphle to access the list of employees rested in capacity (if any) in case, the Branch in-charge/Reader is unable to access the list of employees posted in his/her branch/court for verification as per the above procedure or the role of Branch in-Charge/Reader is not set/specified in their LAYERS login, he/she must contact LAYERS seat immediately.

Individual employees are also directed to check and ensure that their respective Branch In-charge or Reader has verified their details in LAYERS Dashboard by log-in into LAYERS.

The employees verified in LAYERS by their respective Branch In-Charge/Readers shall only be considered as posted in their respective Branch/Courts and all the remaining employees shall be considered w.e.f. 06.10.2021 as posted in Office Paol of Administration Branch - I, II and III, Tis Hazari Courts, Delhi

It must be noted that it is a very important mandatory drive undertaken for the first time in Delhi District Court and any complacency, leniency or non-compliance (if any), by the any employees shall be taken very seriously.
