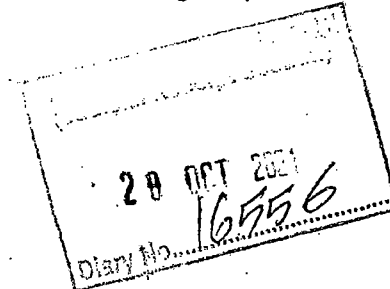
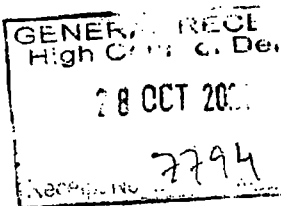
Sub:- Empanelment as KVS Counsel in the Hon'ble Supreme Court of India / High Court of Delhi/ CAT PB Delhi / Lower Court.

Sir,

This is with reference to your letter dated 18.11.2020 giving your willingness to be empanelled in the panel of KVS advocates. The Commissioner, KVS has been pleased to approve to appoint you as one of the Senior Counsel of KVS for entering appearance before the Hon'ble Supreme Court of India / High Court of Delhi/ CAT PB Delhi / Lower Court.

2. The appointment is initially for a period of three years which is likely to be extended at the discretion after taking into consideration your performance in assigned cases.
3. The conditions governing the appointment as Standing Counsel will be as follows:-
 - a) The appointment as KVS Counsel would be terminable on one month's notice in writing on either side.
 - b) When the cases are decided against the Sangathan or its Officers, the Sangathan shall be notified immediately with your considered opinion about the feasibility of further course of action.
 - c) The Sangathan shall be kept informed periodically of the important development, drafting and filing of counters, completion of pleadings, date of hearing, obtaining of certified copies of judgments, interim orders and the like.
 - d) You will be responsible for proper defence of all the cases assigned by Sangathan, even during your absence from station, appropriate arrangement for defence of the case(s) will be made by you under intimation to this office.
 - e) The Sangathan may assign you any other duties of legal nature from time to time.
 - f) You will have the right to continue the private practice which however should not interfere with the efficient discharge of your duties for the Sangathan.

- g) You will not advise any party or accept any case against Sangathan in which you have appeared or are likely to be called upon to appear or advise in any matter which is likely to affect the interest of KVS adversely or lead to litigation against the Sangathan. In the event of failure to comply with the above, your appointment as Standing Counsel will be terminated without any notice.
- h) If you happen to be a partner of a firm of lawyers or solicitors it will be incumbent on the firm not to take up any case against the Sangathan and Ministry of Education arising in the same Court or other Courts and such of those cases of appeal and revision in the Tribunal.
- i) Fees payable to you would be as prescribed by the Govt. of India, Deptt. of Legal Affairs, Ministry of Law and Justice for the Central Govt. Standing Counsels from time to time. It is clarified here that you will not be entitled to any TA/DA/ Hotel Charges/Local Conveyance etc for defending the cases before the Hon'ble CAT, PB, Delhi/ Delhi High Court/ Supreme Court of India and that you will act as a local counsel.
4. The Sangathan will make payment of the fees on presentation of stamped receipt and a certified copy of the Court proceedings/Order/Judgment and for this purpose you will have to submit the bill to KVS within 3 months from the date on which the fee is accrued. The Registrar of the Hon'ble Supreme Court of India / High Court of Delhi/ CAT PB Delhi / Lower Court is being notified about this appointment.
5. The aforesaid appointment will be governed subject to production of undertaking declaring that you had never taken up any case against KVS in the recent past and you will not undertake any court case against KVS and Ministry of Education. You are also requested to submit the certified copies of your educational qualification, PAN Card, cancelled blank cheque of your Bank Account, as well as copy of the registration certificate at the Bar Council for our reference and records.
