
CIRCULAR

SUBJECT:- GUIDELINES REGARDING E-FILING OF CASES.

Pursuant to the directions contained in Minutes of meeting dated 24th November 2021 of Hon'ble Information Technology Committee of the Hon'ble High Court of Delhi vide which it has been resolved that :-

- i) **E-filing is mandatory from 1st January 2022 onwards for all types of cases/ petitions/ appeals/ revisions by Central Government/ State Government/ Local Government Bodies/all Instrumentalities of the State/all PSUs in Hon'ble High Court of Delhi as well as in Delhi District Courts**
- ii) **E-filing of cases U/s 138 NI Act is compulsory.**

All the stakeholders are requested to kindly comply with the above-said directions.




