

Venkataraman [D/205/1996]** R/o 306, Alaknanda Apartments, Sector-4, Vaishali, (Behind Vaishali Metro Station) Ghaziabad, UP-201010, has been suspended from practicing as an Advocate for a period of six months w.e.f. the date of order i.e. **06.04.2022**, vide power vested in the Disciplinary Committee Under Section 35 (3) sub-clause (C) of the Advocates Act 1961 as he was found guilty of committing gross professional misconduct, by the Disciplinary Committee, Bar Council of Delhi, in a **Complaint No. 71/2018** titled "**Ms. Neha Chatwal & Ors. Versus Mr. R. Venkataraman [D/205/1996]**".

As per Section 35 (4) he shall during the period of suspension, be debarred from practicing in any court or before any authority or person in India.
