SMW(C) No. 4/2020

Mr. Gaurav Agarwal, learned Amicus Curiae, submitted that apart from those children who have lost their parents during Covid-19, there are a large number of children in this country who had to dis-

continue their education due to migration of their parents, loss of livelihood of their parents/guardians as well as deficiency in learning processes from online schooling.

The NCPCR is directed to ponder over the suggestions made by the learned Amicus Curiae and submit its suggestions before the next date of hearing.

The State Governments/Union Territories are also directed to submit their responses as to the course of action they would take in ensuring that such of those students who have dropped out due to the adverse effects of the pandemic, would continue in schools.

W.P. (Crl.) No. 274/2020.

After discussing the matter with Ms. Anitha Shenoy, learned senior counsel appearing for the Petitioner in Writ Petition (Crl.) No.274 of 2020, Mr. Gaurav Agarwal, learned Amicus Curiae has submitted a note for the hearing. In the said note, learned Amicus Curiae has brought to our notice that in one of the cases taken up as pilot project for examination of children, who were victims of child trafficking, through video conferencing, i.e., Sessions Trial No.52 of 2019 tried by Special Judge, POCSO Act, Jaipur City – 1, judgment has been

delivered on 22.03.2022. Victims of child trafficking, who are residents of other states, have been examined through video conferencing utilising the facility available in the courts nearer to the place of their residence.

We are informed by the learned Amicus Curiae that the results of the pilot project are encouraging and they need to be continued. A list of pending inter-state child trafficking cases has been furnished to this Court. The Registry is directed to transmit the said list to the Registrars of the High Courts, who in turn will bring the same to the notice of the concerned trial courts.

In case of any difficulty, the court point coordinators and the remote point coordinators shall take the guidance of NALSA, which is willing to coordinate with the relevant participants for the purposes of recording testimony, through video conferencing, of victims of child trafficking from remote points. The trial courts are directed to give preference to recording of evidence of victims of child trafficking, residing in different districts / states, through video conferencing.
