ORDER**

To ensure decongestion in the Regular Courts and in order to assign suitable work to Evening Courts and as approved by the Ld. Principal District & Sessions Judge, NW, following arrangements are being made in regard to NBT challans:-

1. Henceforth, all the Challans pertaining to Notice Branch, shall be filed directly in Evening Courts by the Delhi Traffic Police but NBT Challans viz. Contested & Overdue are first be presented before the Regular Court of Traffic Circle and if the matter does not get disposed off on the first date of hearing before the Regular Court of concerned Traffic Circle, these Challans shall be disposed off in Evening Courts only. For the purpose of presenting these Challans before the Regular Traffic Court Ahlmads of Evening Courts are attached with the Regular Courts of Traffic Circle exclusively for receiving these challans in their register and thenafter putting these challans before the Regular Traffic Court (wherever applicable). It is made clear that these Challans be instituted only in Evening Courts register to avoid multiple entries. Ahlmads of Evening Courts upon receiving NBT challans viz. Contested & Overdue (where SMS through Virtual Court Module have been sent to the violator to appear before the concerned Regular Traffic Courts) shall hand over those challans to the Ahlmads of concerned Regular Traffic Courts one day prior to the date fixed for hearing. And When no one appears in those challans or same does not get disposed off due to any reason before the Regular Traffic Courts, same will be disposed off only by concerned Evening Courts.

2. NBT Challans in which mobile number of violator is not available shall be filed directly in Evening Courts and shall be disposed off only in Evening Courts.

3. All the NBT Challans shall be filed directly in Evening Courts as under:-

It is made clear that Ahlmads of the Evening courts are attached with regular Courts of Traffic Circle exclusively for the purpose of receiving the NBT challans directly in their institution register.
