Sub **Filling up 04 positions of Oath Commissioners in Dwarka Courts, New Delhi.**

Sir

I am directed to inform you that the tenure of 04 Oath Commissioners in Dwarka Courts is going to expire on **25.09.2021**.

You are therefore, requested to invite applications and send your recommendations for said positions of Oath Commissioners in the light of extant guidelines reproduced below in the prescribed proforma (copy enclosed) -

Guidelines for appointment of Oath Commissioners in all Courts including Income Tax and Sales Tax.

1. An applicant for the appointment as an Oath Commissioner should have 3 years practice as an Advocate on the last date of submission of application form and the advocate applying for appointment in a particular Court Complex, should be mainly practising at the said Complex.
2. The tenure of appointment of Oath Commissioner in all Courts shall be of 2(two) years, unless otherwise ordered by the High Court.
3. An advocate can be considered for re-appointment after a period of 3 years from conclusion of his/her earlier term.
4. The average annual income for an applicant for appointment as an Oath Commissioner should be not less than Rs. 24,000/- per annum during the preceding two years.

In support of proof of income, the applicant shall file an affidavit in the absence of any other proof.

Provided that the income criteria will not be applicable in case of persons with disability and lady advocates, who are divorcee/widowed/single.

5. Preference to the extent of 10% will be given to senior citizens, lady advocates, who are divorcee and widowed, and persons with disability, subject to their furnishing the requisite proof in order to claim appointment in any of the preferred categories.

You are, further requested that while sending the recommendations for filling up the positions of Oath Commissioners, you are requested to recommend atleast 20% more names for consideration for filling up the requisite number of positions in the said Court Complex.
