This is in continuation to this office earlier Circular No. 11770-11920/Comp./Mobile/2014 dated 30-04-2014 on the above subject, it is also to convey that pursuant to the Minutes of Meeting dated 29th April, 2014 of Mobile Committee duly approved by Id. District & Sessions Judge (HQs), Delhi, the Committee has recommended that in the event of the officer eligible to avail limits prescribed in letter no. F.1/80/05-Judl./Suptlaw/470 dated 16th April, 2014 desirous of purchasing mobile phone, though he/she had purchased the mobile phones less than two years ago, is entitled to avail of the depreciation as per OM No. F.2/883/CTB/GAD/2012/3126-27 dated 24-09-2013 (50% for Year-1, 25% for Year-2, 15% for Year-3 and 10% for Year-4) and on deposit of depreciated book value of the mobile with the office of Id. District & Sessions Judge (HQs), Delhi.

Furthermore, all the Officers are required to submit the original bills for reimbursement to this office.
