
CIRCULAR

In modification to this office Circular No. (s) 35763-35799/F2(12)/Judl./RC/19 dated 05.12.2019 (N-W) and No. 36335-36353/F2(12)/Judl./North/RC/19 dated 06.12.2019 (North) and any further circular/order in this respect, it is clarified that Hon'ble High Court of Delhi, vide Minutes of Meeting of State Court Management Systems Committee (SCMSC) held on 12.02.2019, had directed that cut-off date for application of amended provisions of the Commercial Courts Act, 2015 has to be taken to be 03.05.2018 as prescribed in Section 19 of the Amending Act 28 of 2018.

It is brought to the notice of District Judges (Commercial Courts) and Additional District Judges that as per Section 19 of the Commercial Courts, Commercial Division and Commercial Appellate Division of High Court (Amendment) Act, 2018 (Act 28 of 2018), the application of the provisions of the Commercial Courts Act shall apply **only** to cases relating to commercial disputes filed on or after the date of Commencement of this Act. Since the amendments were brought w.e.f. 03.05.2018, only the cases having commercial disputes filed on or after 03.05.2018 shall be transferred from the court of Additional District Judges to the courts of District Judges (Commercial Court).

It is further ordered that if the cases instituted prior to 03.05.2018 are pending in the court of District Judges (Commercial Courts), the same are hereby transferred to the courts from where the said cases were received in the court of District Judge (Commercial Court).
