- Court should not insist on the presence of the parties unless it is unavoidable. 1.
- Till the present situation of Coronavirus (COVID-19)persists, no adverse/default orders be passed 2. in matters where parties are found to be absent.
- Parties/Advocates/Witnesses seeking an adjournment be accommodated. 3.
- In criminal matters, the request for exemptions from personal appearance of the accused be 4. considered favorably.
- In civil matters, wherever possible, service of local commissioner be availed of for the 5. purposes of recording of evidence, after obtaining the consent of both the parties.
- The facility of video-conferencing be put to optimum use for the purposes of recording of 6. evidence.
- Instead of physical production of UTPs from jails, facility of video-conferencing be availed of. 7.
- In final argument matters, as far as possible written submissions be called upon to be 8. submitted in the court and the time for oral arguments be reduced to be extent possible.
- All the possible preventive and remedial measures be taken to combat the impending threat of 9. COVID-19 by all the Ld. Judicial Officers and also in their respective court room at individual level.

Ld CMM of both districts are directed to ensure that the Rehnumai and detention of Remand is done 10. only through video-conferencing by all the Metropolitan Magistrates.
