**Subject : Directions qua receipt of replies to the bail applications before the Duty Judge/  
MM.**

It has been reported by the Prosecution Branch of North & North-West District, Rohini Courts that the replies to the bail applications are being sent timely to the e-mail (s) of the concerned court(s) but Duty Judge(s) are adjourning the matters on the ground that replies have not been received.

Therefore, in case reply to any bail application is not received from the Prosecution Branch, the Duty Judge will direct their Reader to contact Prosecution Branch at Mob. No. 9306256113 (for North) & 9811795090 (for North-West) for reason of delay.

Further, whenever any reply is not received, the Duty Judge shall direct the Public Prosecutor posted in his/her court to ensure that reply is sent by the Prosecution Branch well in time.

If despite that, Prosecution Branch does not send the reply till 2:00PM then Duty Judge may contact and inform qua the same to Chief Prosecutor of respective district i.e. North & North-West and mention the same in order-sheet for the day.

Reader of the concerned Duty Judge is also directed to regularly check the E-mail till 3:00PM and shall mention the e-mail ID of the court in the cause-list so as to enable the Prosecution Branch to send its replies well in time.

The Duty Judge(s) are impressed upon to ensure that reply is duly filed by the Prosecution Branch on the date already fixed so that the matter are not unnecessarily adjourned.
