**Note :-**

1. Since the functioning of the District courts of Delhi stands substantially restricted, there is no requirement for the entire workforce of court officials to report for duty on a daily basis.
2. All staff officials reporting for duty, shall submit the declaration form (Annexure A) as per the directions.
3. On the day, when Ld. Officer is coming to the court, Reader, one Stenographer and Ahlmad / Asstt. Ahlmad is required to report for duty. On days when the Ld. Officer is not coming to the court, one staff, either Ahlmad or asstt. Ahlmad shall report for duty for presenting the case file before the Ld. Link MM. All those staff officials who are not required to report for duty on any given day, would not leave the station under any circumstances, they would always be available on call and would be deemed to be on duty. In case of any urgency, they may be called upon them to report back for duty immediately.
4. Reader of the courts would ensure that the requisite details with respect to next date of hearing and its purpose is uploaded through case information system (CIS) on the same day.
5. Only urgent applications of her / his will be heard by the officers available in the court on their day on duty and rest of the matters will be adjourned.
6. Senior most Magistrate on duty shall exercise power of CMM.
7. Duty Magistrate Roaster of the month of March shall remain unmodified during the aforesaid mentioned period.






