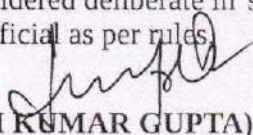

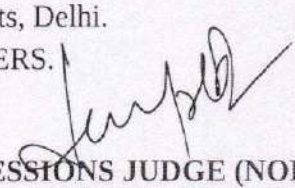
Notes:-
